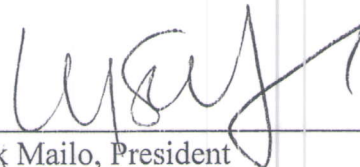
AN ACT

Authorizing the sum of \$3 million dollars from Chuuk State "Compact prior year un-allocated fund" for the purpose of funding Chuuk State's contribution to the construction of the College of Micronesia Chuuk state Campus and access roads, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

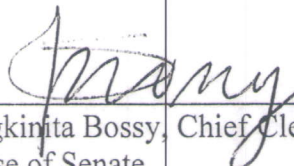
1           Section 1. Authorization. The sum of \$3 million dollars or so much thereof as may be  
 2 necessary is hereby authorized from Chuuk State "Compact prior year un-allocated fund" for the  
 3 purpose of funding Chuuk State's contribution to the construction of the College of Micronesia  
 4 Chuuk State Campus and access roads.

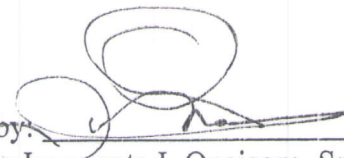
5           Section 2. Effective Date. This Act shall become law upon approval by the Governor, or
